A rollover extends this contract by one month, and Member may use the rolled over session within 12 months of original issue date so long as your account remains active and in good standing. Satori Members are entitled to 10% off retail products, and those Members who have more than one 60 minutes session within a month will enjoy savings of 20% off from regular rates. There may be additional benefits of Membership as determined by Epic Bodyworks. This Membership may be shared by ONE additional person identified as an Associate Member and they will receive the same benefits.

### MEMBERSHIP CANCELLATION

To cancel this Membership, write your request for cancellation 30 days before your next monthly auto payment and mail, email, or hand your request to us. In the event of failed payment or inappropriate conduct by you or your Associate Member (as determined by Epic Bodyworks staff/Management at its sole discretion). Epic Bodyworks reserves the right to terminate your Membership, excluding termination for inappropriate conduct, you acknowledge and agree that any unused prepaid sessions must be used sixty (60) days of the date of your last auto payment, after which time any remaining unused sessions will be forfeited. No refunds will be issued for forfeited sessions. Early cancellation of your Membership coincides with a penalty fee of \$10 per month of your used Membership.

### APPOINTMENT CANCELLATIONS

Appointments may be cancelled without charge up to 24 hours before the appointments scheduled start time. Cancellations made less than 24 hours advance notice may be charged a "Late Cancellation" fee of \$40 up to the full cost of the booked session as determined by Epic Bodyworks. The cancellation fee is to cover the cost of your Massage Therapists time.
